TUITION & FEE SCHEDULE

INFANT PROGRAM

Ages 6 Weeks – 2 Years

SCHEDULE	TUITION
Full-Time Care (4–5 days/week)	\$370/week
Daily Rate (1–3 days/week)	\$100/day
Full-time daily equivalent: \$92.50/day	



PRESCHOOL PROGRAM

Ages 2–5 Years

SCHEDULE	TUITION
Full-Time Care (4–5 days/week)	\$310/week
Daily Rate (1–3 days/week)	\$85/day
Full-time daily equivalent: \$77.50/day	



SCHOOL-AGE CARE

PROGRAM	TUITION
Before School Care	\$100/week
After School Care	\$125/week
Before & After School Care	\$177/week



LATE PICK-UP FEES

HoneyPie Nature PLAYschool closes promptly at 5:00 PM.

TIME	FEE
5:00 – 5:05 PM	\$10
Each Additional 5 Minutes	\$20



LATE PAYMENT FEES

Tuition is considered late after Monday at 5:00 PM.

DAYS LATE	FEE
More than 3 days late	\$40 per day

Tuition balances more than 2 weeks overdue may result in suspension of care until payment arrangements have been made.



RETURNED PAYMENT (NSF) FEE

A fee of **\$25** will be charged for any returned check or failed payment due to insufficient funds.

TUITION POLICIES



Tuition is due Monday by 5:00 PM for the upcoming week of care.



Tuition reserves your child's enrollment space and is based on your contracted schedule.



Tuition is not reduced for:
Illness • Vacation • Scheduled Holidays
Absences • Missed Days



Schedule changes must be approved by the provider.



Families will receive a minimum of 6 weeks notice before any tuition increase.

ADDITIONAL FEES



ENROLLMENT & RE-ENROLLMENT

\$100 annually (Due each September 1st)



EXTRA HOURS / DROP-IN CARE

\$20 per hour (Outside contracted hours)



FIELD TRIPS

Additional fees may apply and will be announced prior to each trip.



IMPORTANT REMINDERS

- Contracted hours are your child's approved attendance hours.
- Early drop-offs and late pick-ups may result in additional fees.
- Third-party payments (employer assistance, Wisconsin Shares, etc.) must be arranged in advance.
- Financial terms are finalized upon signing the Parent-Provider Contract.
- Parents/guardians under age 18 must have a co-signer.
